

Black River District Council (Collection and Disposal of Refuse) (Amendment) Regulations 2005

GN No. 43 of 2005

THE LOCAL GOVERNMENT ACT 1989

Regulations made by the Black River District Council under Sections 51,141 and 142 of the Local Government Act 1989

1. These regulations may be cited as the **Black River District Council (Collection and Disposal of Refuse) (Amendment) Regulations 2005**.

2. In these regulations: -

"Principal Regulations" means the Black River District Council (Collection and Disposal of Refuse) Regulations 1997

3. The following sections and the schedule to the Principal Regulations are hereby amended:

Section 2 - deleting Principle Health Inspector and replacing it by Chief Health Inspector.

Section 4 - adding paragraph (d)
with 3 months from the publication of the present regulations in the Government Gazette submit to the Council a declaration confirming that ownership or occupation of the land and shall keep the Council informed of all changes in such ownership or occupations within one month of such change.

Section 16 (a) deleting Rs500 and replacing it by Rs 1000.

(b) deleting 16(b) and replacing it by: "for an offence under any other regulation to a fine not exceeding Rs 10000 and shall in the case of a continuing offence, be liable to a fine not exceeding Rs 1000 for each day during which the offence continues after conviction".

3A. For the removal of refuse per service from restaurants, hotels and boarding houses, Tourist Residence/guest house or by an agreement made under regulation 11 (2) and 11 (3)

(a) 1 Lorry Load.....Rs 500

(b) Every ½ Lorry Load or Fraction thereof.....Rs 350

3B. For the removal of refuse from the following trade premises per month per premises.
